in writing by contacting the main office of the student's school.



## Clarenceville School District Staff Technology Acceptable Use Policy Agreement

As a user of the Clarenceville Network, I understand and agree that my participation on the Internet is to develop my communication skills and exchange information that is of an educational nature. I understand I must agree to the following conditions in order to use the Clarenceville Computer System, both on and off the Internet.

It is my right to use the Clarenceville Computer Network only so long as I maintain the responsibilities below:

- I understand that the purpose of the Clarenceville Computer Network is to further my personal
  growth in technology and communication skills. It is prohibited to use the technology resources
  for commercial, personal or private business, product advertisement, fundraising, campaigning, or
  political lobbying. I will access only resources on the system which are approved or specifically
  for the instruction of my students.
- I will not attempt to bypass security to access files, Internet sites or resources.
- I will use only network accounts which belong to me, or to which I have been purposely given access.
